**ORDER**

Provisional affiliation was granted for Bethania Institute of Management Studies, Kunnankulam P.O, Thrissur with the self financing programmes BCom Finance (40), Bachelor of Business Administration Finance (30) and Bachelor of Computer Application (24) for the academic year 2023-24, vide University Order read as first.

2. The Principal, vide the paper read as second has requested to grant Continuation of Provisional Affiliation to the above mentioned programmes for the academic year 2024-25.

3. Accordingly, vide University Order read as third, an Inspection Commission was appointed to verify the instructional and infrastructural facilities available at the college. The Commission, after Inspection, recommended Continuation of Provisional Affiliation to the programmes.

4. Considering the above, Sanction has been accorded by the Vice Chancellor to grant Continuation of Provisional Affiliation to the following self financing programmes as detailed below, at Bethania Institute of Management Studies, Kunnankulam P.O, Thrissur for the academic year 2024-25 on conditional basis subject to the submission of Renewal of NOC from Higher Education and with strict directions to the Principal to engage faculties having required qualification as per the UGC regulations and in compliance to the provisions under Act 13 of 2021 Kerala self financing college teaching and non teaching employees (appointment and conditions of services).

5. Orders are issued accordingly with the following terms and conditions.

- The Principal shall strictly follow the syllabi available in the University website [www.uoc.ac.in](http://www.uoc.ac.in) for selecting complementary courses.
- The complementary courses/common courses specified in this order are based on the details of

registration of candidates for examination and shall not be treated as a factor for calculating the work load for the subject/for the requirement of teaching faculty, for which competent orders shall be obtained from the Govt/University.

- Selection and admission shall be made only on the basis of the rules and regulations of the University/Government and on the basis of the directions issued by the University/Government from time to time.
- In the light of the directions of the Supreme Court of India in WP (C) 656/1998, the institution shall take stringent measures for prevention of ragging in any form.
- Affiliation granted is strictly provisional and only for the academic year 2024-25. The college has to apply for CPA for the ensuing years remitting the fee fixed by the University, along with the extension of approval orders, if any, from the apex bodies concerned.
- The Office of Controller of Examinations shall ensure that examinations are not conducted in those colleges which do not have valid continuation of provisional affiliation orders.
- The conduct of University Examinations of any sort including that of the SDE Examinations is compulsory and binding on all colleges affiliated to the University of Calicut.
- The college is liable to comply with the general conditions stipulated in the renewed NOC from the Govt. of Kerala for the academic year 2024-25.
- Admission to the next academic year shall be made only after obtaining prior permission from the University.
- Violation of any of the above will lead to the cancellation of affiliation.
